WAIVER & RELEASE

Please read the following carefully and sign at the bottom of the page, covering over the light print inside the box.

In consideration of my being allowed to use **climb 306 ltd.** climbing wall and related training facilities, I the undersigned, hereby agree and acknowledge the following:

1. **ASSUMPTION OF RISK:** I hereby acknowledge and accept and agree that the sport of rock climbing and the use of **climb 306 ltd.** climbing wall involve inherent risks. I received full information and the opportunity to examine the climbing wall and ask any questions that I wished. I have full knowledge of the nature and extent of all the risks associated with rock climbing and the use of the climbing wall, including, but not limited to:
a. All manner of injury resulting from my falling off or from the climbing wall and hitting the floor, wall faces, people or rope projections, whether permanently or temporarily in place;
b. Rope abrasion, entanglement and other injuries resulting from activities on or near the climbing wall such as, but not limited to climbing, belaying, repelling, lowering on ropes, rescue systems, and any other rope techniques;
c. Injuries resulting from falling climbers or dropped items, such as, but not limited to, ropes, climbing hardware or wall parts;
d. Cuts and abrasions resulting from skin contact with the climbing wall or any other surface;
e. Failure of ropes, slings, climbing holds, anchor points, or any part of the climbing wall;
f. Failure to follow **climb 306 ltd.** instruction or failure to ask for information.
I further acknowledge that the above list is not inclusive of all possible risks associated with the use of the climbing wall and related training facilities.

2. **RELEASE:** I hereby release and discharge **climb 306 ltd.**, its owners and affiliates, agents and employees, and their successors and assigns, from any and all liabilities, suits, claims and demand actions or damages (including attorneys fees and disbursements) incurred by me arising out of the use or intended use of the climbing wall, including, without limitation, all claims for claims for property damage, personal injuries or wrongful death except to the extent that such loss or damages is caused by or resulting from the gross negligence of any such party. This release is binding on my heirs, assigns and agents. If I see or hear anything I feel is questionable or dangerous, it is my responsibility to ask or inform **climb 306 ltd.** employees, until corrected or satisfactorily answered.

3. **INDEMNIFICATION:** I hereby agree to indemnify and hold harmless **climb 306 ltd.**, its owners, affiliates, agents and employees, and their successors, and assigns, from any and all causes of action, claims, demands, losses and costs of any nature whatever arising out of or in any way relating to my use of the climbing wall, except to the extent that the same is caused by or results from gross negligence of any such party. This indemnification is binding on my heirs, assigns and agents.

4. **AGREEMENT TO FOLLOW SAFETY POLICIES OF climb 306 ltd.** I accept full responsibility for my own safety and the safety of other climbers while on the premises of **climb 306 ltd.** or its affiliates. I agree to abide by and enforce the following safety policies:

- 1) All climbers must participate in the climbing wall orientation, must be familiar with the following policies, and must have signed and filed this form with **climb 306 ltd.** to be allowed to climb on the climbing wall.
- 2) All climbing wall users must undergo a belay skills test in order to become a qualified user. New belayers will be trained and qualified by a **climb 306 ltd.** climbing wall supervisor.
- 3) All unbelayed climbing is prohibited except in the designated Bouldering Area with height of feet only off the ground 8'.
- 4) All climbing equipment not provided by **climb 306 ltd.**, must be approved by the **climb 306 ltd.** climbing wall supervisor or climbing wall Instructor.
- 5) All belayers climbing must be on **climb 306 ltd.** provided ropes and must be belayed through a belay plate or similar device. Roped climbers and belayers must wear approved harnesses.
- 6) Climbers will tie the rope directly into their harness with a figure eight follow through knot with a single or double prusik safety knot.
- 7) All climbers must inform **climb 306 ltd.** and all other climbers of any situation seen as unsafe or not in accordance with the Safety Policies. All climbers are asked to assist and encourage less experienced climbers. All accidents or equipment damages must be reported immediately.

climb 306 ltd. reserves the right to deny access to its facilities to any individual permanently or for a specified period of time for breach of any of the Safety Policies, or for any conduct that is viewed as unsafe or inappropriate.

As part of this contract, my consideration of the usage of **climb 306 ltd.** climbing wall, I acknowledge with my signature that **I have read and agree to abide by the terms of agreement.**
